## PHIL-A-TELIC:

The challenge has been met so the owner of the question in the November Newsletter can follow through on our agreement and send Phil the other question poste haste:

Dear Phil: The stamps which you are trying to identify (Newsletter #203) belong to one of the numerous bogus fabrications massively produced in the Russian occupied parts of Europe immediately after the Armistice. This kind of bogus overprint - the coat-of-arms of Czechoslovakia - is mentioned in the Michel catalogue, Eastern Europe - "Tschechoslovakei". The bottom line of the overprint obliterates the original inscription: BOHMEN and MAHREN CECHY a MOZAVA

The original stamps used for this fabrication are listed in Scott Vol. 2 (Czechoslovakia - Bohemia and Moravia) #80, 81, 82 and 83. Hope that this will help to solve the Truro mystery, Sincerely, Nik

PAPER CHASE: The Amenities of Stamp Collecting, Alvin F. Harlow. New York: Holt, 1940. pp. 218, 219

<u>Treasons</u>, <u>Stratagems</u> and <u>Spoils</u>: Airplane flights have been a favourite method of exploiting the collector, from the time of Henry Hawker's flight across the Atlantic in 1919. Some covers have brought in fancy prices after years, one carried by De Pinedo in 1927 has sold for \$3500. When Darius and Girenas planned a flight from New York to Lithuania in 1933, their propeller was in hock for repairs, they announced that they would get up a cachet and carry letters. As both were killed landing on the other side, it was an unfortunate idea.

A planeless pilot who wished to fly from Minnesota to London organized Aerial World Tours, Inc. persuading the Newfoundland Government - for a promised consideration of \$80,000 - to permit his company to print 400,000 so-called air-mail stamps of \$1 face value, which were to be canceled by the St. John's Post Office. The promoters were to sell these stamps to collectors at 400% profit! After being printed in the U.S., the stamps were delivered to Newfoundland, and the promoters started selling to philatelists. In addition to the dollar charge, there was a handling fee of 10¢ per order, plus postage and registration. Covers could be registered for an additional 50¢, and a further 50¢ would get you the crews' autographs. The company would not guarantee delivery of any covers. A storm of protest from philatelic editors, and cataloguers caused Scotts to refuse to countenance the stamp, and the Newfoundland government to repudiate the whole deal.
